ABOUT BAT RESCUE INC.

Formed in June 2002, Bat Rescue Inc. is an incorporated, non-profit volunteer organization based on the Sunshine Coast. The membership also includes supporters from other areas of South-East Queensland, interstate and overseas.

Active (carer) members are permitted under DERM (Department of Environment & Resource Management) to care for sick, injured and orphaned wildlife. Bat rehabilitation is a unique branch of wildlife caring as vaccination against Australian Bat Lyssavirus (ABL) is required. Volunteers respond to large numbers of rescue emergencies involving bats which minimizes the risk of exposure to ABL within the community.

Members of Bat Rescue Inc. work closely with vaccinated veterinarians who have an interest in bats and provide invaluable support for our work.

Bat Rescue Inc. is dedicated to:

- *Providing education and information to the general public*
- *Active conservation of bats and their habitat*
- *The promotion of bats as an important part of our ecology*
- *The rehabilitation and release of bats back to the wild*

President's Report



Some extremely important initiatives were implemented this year, including the fencing over dam project, business cards and flyer education blitz near newly-formed colonies. In addition, our usual activities took place including publicity, fundraising, education and promotion events.

An enormous amount of time was also spent during the lead-up to and implementation of the organizational changes. Lockyer Valley branch having decided to leave Bat Rescue Inc and form their own organization (Bats QLD Inc) was the catalyst for the change.

The Gold Coast branch had operated very successfully since 2005, however with the overseas departure of the Co-ordinator Vicki Bressan, her role left a huge gap in the branch operations. Despite the efforts of the Lockyer Valley Co-ordinators to support the Gold Coast branch, and the members' willingness to continue as a branch of Bat Rescue, this was at odds with their stated desire to become more independent and autonomous over most activities the branch carried out. With the Lockyer Valley Branch already scheduled to cease operations on 30th June 2010, the decision was made that it was in the best interests of the organization and for carers located in the Gold Coast region that they also cease operations on that date and could then either form their own organization or join other locally based organizations that could provide a more localized support network for those carers. Bat Rescue Inc. will be a more compact organization from now on, representing the Sunshine Coast region - although a few members from other areas have elected to continue their membership with us.

Time will tell whether the decision to cease Branch operations was the correct one; however as a group of volunteers managing an increasingly larger group of people spread out over a great distance is very difficult to achieve on the limited time people have these days to devote to volunteering. As well as the active caring, administrative jobs, training and mentoring new members, fundraising and public education, it is a huge job and very time-consuming for the few that are often carrying the majority of these responsibilities.

Training was conducted across the region by Lockyer Valley and Sunshine Coast, and crèche and release was managed by the Longgrass crèche site and Peachester release site. An extended support feeding period was required due to the food shortages across the board, and thankfully it was a very quiet season in comparison to previous years. Hopefully we will have another quiet one.....fingers crossed.

A big thank you to Carmel Givens, Lyn Boston and Leanne Baird for their input on the committee. Many thanks also to Vicki Bressan who manages the website, edits the newsletter, and any other administrative task that is possible to manage from her remote location. Thank you also to Danielle for her help with the sponsorship program and as teat maker. Chocolate sellers Megan and Lahnee did an incredible job at selling chocolates. Finally thanks to all the members who spend hours of their time and resources caring for all the bats that come into our care.

Treasurer's Report



This year Bat Rescue received a grant from the Maleny Credit Union of \$800 to fix a notorious hot spot for entanglements in Peachester over a dam. For years this site had caught numerous bats that involved difficult rescues from the water. The owner of this property kindly agreed to replace the wire with plain wire and was fully funded by Bat Rescue. The rest of the money was used to buy trawler netting for much needed renovations on the release facility.

We made our annual donation to the Currumbin Wildlife Hospital of \$500 to assist in their ongoing treatment of native fauna, and in particular the many bats they treat in the area. We appointed a Grants Officer this year, Jenny Singfield, who has been busy with submissions, and we thank her for her work in submitting some this year for which we awaiting the outcome.

Our chocolate sales are down from last year however we have had a couple of large orders for T-shirts from our supporters in Italy, Cesare and Lina Piazza. Sponsorship and donations are also down. Many thanks to Danielle and Vicki for resurrecting the sponsorship program this year. Sponsors last year unfortunately did not receive the expected sponsorship package which was reflected in this year's downturn. We hope it will pick up again next financial year. There was a slight increase in sausage sizzle fundraising as all branches conducted one sizzle each and they are a very profitable fundraising exercise. Many thanks to all those who participated in the fundraising events held throughout the year. Overall income was down around \$1500 compared to last financial year.

The cost of bat food for orphan season was down by around half of last year's expenditure. This was due to the availability of free fruit that BRLV were able to source, and there were fewer bats in care. There are still however costs for the extended support feeding period that will be reflected in the financial statements next year. We purchased quite a number of equipment items to sell to members such as heat pads, thermometers and calipers as carers were finding it difficult to source these items. Quite a bit of research went into sourcing heat pads after it was discovered that the Breville heat pads had auto cut-out mechanisms in the new models. Overall our expenditure was down by around \$500 on last year.

Our financial position as at June 30, 2010 is \$4465.45 in assets with a further \$32,358.47 in fixed assets such as equipment, giving overall total assets of \$36,822.92. The fixed assets reduced slightly from last year as some equipment was unrecoverable when the branches closed.





ACHIEVEMENTS 2009/2010

Membership

As at the end of the financial year there were a total of 56 members (active and support). This included 13 new active members recruited during the 12 month period, and two new support members.

Grants

\$800 Maleny Credit Union kindly donated funds for some important projects.

This grant was used to fix a notorious hot spot for catching bats across a dam. Approximately \$300 was spent changing this fence to a plain wire fence. The balance was used to purchase more trawler netting for lining the release aviary. This was important as the cage was in need of some revamping. Carmel Givens was instrumental in obtaining this grant for the organization and coordinating each project funded by the grant.

Newsletters



Four editions of *Night Wings*, Bat Rescue's quarterly newsletter, were produced during the year. In order to be more environmentally friendly and cost-efficient, newsletters were made available on the website. While the majority of members are now able to access the newsletter online, a number of hard copies are also circulated to a distribution list of Associate members, supporters and other outside organizations.

The newsletter is edited by Vicki Bressan, a task she took on four years ago.

Website & Online Records System

During its fifth year of operation, the website continues to achieve high search engine rankings and surprising visitor numbers. Hitlog statistics record a total number of 19,475 visitors between 30 June 2009 and 1st July 2010 who viewed a total of 46,688 pages! We received a total of 109 enquiries via the website during the reporting period. While most of these emails were local or interstate, we also responded to a number of overseas enquiries including from USA, UK, Turkey, Kenya, New Zealand, Holland, Italy, Colombia and Malaysia.

Updates made to the website this year include various minor tweaks to the content, the addition of a new Hendra page and the availability of various documents and forms in the Members section.



The Online Records system continues to play an integral part in Bat Rescue's daily operations. A few enhancements were added during the year including the introduction of a benchmark parabolic orphan growth chart proposed by Dave Pinson. The straight line growth chart (originally developed by Linda Collins) was also retained for the 2009-2010 orphan season.

All aspects of the website are managed remotely by Vicki Bressan, and free hosting (for which we are extremely grateful) continues to be sponsored by Brett Warner of Figjam Design.


Project Activities

At the previous Annual General Meeting, a suggestion was made by Sue Richardson regarding an education strategy for the community around the Peachester colony and the newly formed Landsborough colony. After some discussion it was decided that a business card should be produced with contact details of who to ring when people in the community find a bat. This was to be accompanied by an informative brochure *Living with Flying-foxes*.

The business card was printed at Queensland Complete Printing, winners of the 2009 Sustainability Awards. They also attached magnets to the back of a number of them so that people could put them on their fridge. As we could not source enough copies of the brochure we had them reprinted. Overall the project cost the organization \$813.90 but we felt it was an important strategy to implement as soon as possible.

A batch was sent to the Gold Coast and Lockyer Valley for distribution, and on the Sunshine Coast it was decided to distribute these through the school system. The schools in the areas of Landsborough, Beerwah, Peachester, and Glasshouse Mountains were sent a letter introducing ourselves and offering to deliver this material. This was followed up by a phone call asking for a convenient time to deliver the material. It was the most efficient way to disseminate the information via the school system, as it was most often children that were finding bats.

At least one call for an orphan was attributable to the card and brochure in the backyard of a residence backing onto the Landsborough colony. Although not a fan of the bats living there the person recognized it was an orphan baby flying-fox and knew who to ring for help. Letter box drops were also done around areas bordering colonies, and all members were sent a batch of cards to use and disseminate or use as business cards to hand out at rescues.

RELEASE REPORT



First pre-release intake arrived Thursday 4th February, by this time there were some greys back in the camp, though in reduced numbers. Blacks have been present on a neighbouring property on a consistent basis. Snakes were caught and removed on the 6th, 10th and 12th of February, whilst these bats were settling in.

Throughout the release season, feed was apportioned at a start of 300 grms per bat, and rapidly adjusted up or down, usually settling at 350- 375 grms per bat, which

amounts to feeding on demand. This reduces wastage, and ensures that no one goes hungry. Feed is assessed by leftovers, and adjusted until there is either 3 or so pieces left, or feeders are empty. Each bat is given 10 grms HPS per day. Feeding disturbances are also taken into account, such as snakes present, so that any leftover feed in a particular given area, was not taken into account in the feed adjustments, as a false appetite assessment. At no time was there any excess droppage during the entire 2010 release season.

First intake released 25th February. All bats left aviary. No bats in on the 26th, but one seen hanging near aviary. On release these bats were being fed 3.7 kg of fruit, 100 grms HPS. Weather began to turn wet. By 12.30 am on the night of the 26th, several bats were inside feeding. Rain became torrential on 27th.

Three bats were back inside the aviary, something had spooked them. Two feeders were left untouched. A snake was caught and removed 3am.

Second pre-release arrived March 1st. Hatches were closed to release 1. Another snake caught and removed. 1 bat which was refusing to leave the aviary was taken in and resettled with crèche 2. Weather by this stage was very wet, often torrential. 2nd March, 3 more bats were brought back in, one with a lower eyelid injury. This bat was taken to the zoo the next day, and declared to be healing well, no damage to eye itself. These additional crèche 1 bats were toe ringed.

Weather by this time had become almost constant torrential downpour, and more crèche 1 bats were brought back in. I made the decision to split the cage, and separated back out the crèche 1 bats, except for the first back in, and removed toe rings. By this time, there were 8 bats in crèche 2, and 7 bats in the other end, retrieved from wet release conditions. Floor of the aviary was consistently underwater at this time, and much local flooding. Apples were strung by this stage on the outside for the others, as there was no hope of keeping HPS on fruit, and feeders would flood. Other bats still coming to the cage to feed, but a snake was present, but out of reach. Snake had gone by the 4th.

8th March, rereleased crèche 1, closed hatches 1am on early in the morning of the 10th. Heavy showers again on the morning of the 10th, two bats were hanging on outside aviary in rain, and

dog alerted me to a hawk attack on these two bats. Dog saw hawk off, bats brought into the vestibule until risk was past, and then decided to bring bats back in with crèche 2, as they were wet and appeared not to be coping well. By this time, feed inside was 3.5 kg, and outside was 5 kg. Another snake was caught and removed 12th March. Rescued juvenile bat “Braidy”, black male, 280 grms was placed into crèche 2 for weight gain.

Crèche 2 released 22nd March 10 pm. “Braidy” held back for 3rd crèche to be monitored with Frieda.

At this time there was 4.5 kg outside. Obviously, there was not enough to go around with food shortages, so this was upped to 6.5. All bats consistently ravenous. One bat was held back with crèche 3. This food was upped yet again, as it appeared that larger bats were taking food, and the newly released bats were simply going hungry. By this time, there was a major food shortage caused by the heavy rains. The food was then upped by a kg, as there were five hungry bats hanging on the outside of the cage. This was reduced to 6.5 again by the 26th, as these bats learned to be in early for feed. Over the next week, there were always between 1 and 3 bats hanging on aviary, though they seemed to be coping.



Hatches were opened for crèche 3 April 5th. Sudden heatwave. Snake was caught and removed 9th of April. Feeding was erratic due to snake activity from warm spell. 11.30 pm on the 10th April, about 14 bats were found trapped inside cage by large snake on the floor. Snake caught and removed immediately, (empty bellied), and 3rd hatch opened to allow frightened bats exit. Returned 1 am to close all hatches.

Majority of bats began migrating around 21st April, but migrate and return pattern erratic. Food shortages saw support feed continued throughout winter, with a prolonged period of 5kg per day strung. Camp emptied by 26th of May, but with periodic return of local blacks. Some cut fruit still placed for last crèche and some HPS where weather allowed use.

Reduced feed coinciding with spring, last apple placed on aviary 28th September 2010. Release season closed, blossom now available. All bats, to my knowledge, now successfully integrated and self feeding.


